**DEDICATION OF BOLIN ROAD (TOWNSHIP ROAD 746) LOCATED IN COLUMBIA TOWNSHIP, MEIGS COUNTY, OHIO - (GRANTED / DENIED)**

WHEREAS, on the Columbia Township and landowners questioned status and maintenance responsibility for an existing service road located in Fraction 35 and Section 29, T9N, R15W, of the OCP,

WHEREAS, on July 27, 2020 the Engineer's office reviewed the status of the service road with the County Prosecutor and on November 5, 2020 the Prosecutor recommended that appropriate steps to make this a township road should that be the decision made;

WHEREAS, on November 5, 2020 Eugene Triplett, County Engineer, recommended holding a public viewing and hearing to discuss the dedication of the service road as township road, as described below, to-wit:

Beginning at junction of SR689 and abandoned SR346; thence westerly along a portion of abandoned SR346 (Journal of Highways V55 PI 132); thence southwesterly along a service road constructed as part of ODOT MEG-346-0.00 to east line of Section 34 and a 16.617 acre parcel described in Meigs Co. OR V387 P3019.

a 60' wide right-of-way of the portion road that occupies abandoned SR346 and land described as State Parcel Nos. 256, 257, and 253LA for a Service Road in Meigs County Deed Record V387 P3019.
